1.) Class Leader/Facilitator Services.

parties hereto agree as follows:
a.) Class leader/facilitator shall provide weeks/days/hours of educational services.
b.) Class leader/facilitator shall diligently and competently perform duties of class facilitator.
c.) Class leader/facilitator shall be respectful, cooperative and civil with parents/guardians,
students, board members, staff and other independent contractors at all times.
2.) Agreement term.
The term of the class leader/facilitator services shall commence on,and
shall terminate on,; unless sooner terminated by either party as provided
in this agreement.
3.) Compensation.
In full consideration for the performance of the services hereunder, the parents/guardians of the
student shall pay the class leader/facilitator as follows (check as applicable):

4.) Termination of agreement.
This agreement may be terminated by the class leader/facilitator at any time upon giving the
Encourager's Co-op 30 days notice of intent to do so. Encourager's Co-op may terminate this
agreement upon any breach of this agreement or any other good cause (such as classes not
filling or space considerations) or upon the dissolving of the Encourager's Co-op for any reason
5.) Payments to class leader/facilitator upon termination of contract.
In the event of the termination of the class leader/facilitator pursuant to section # 4 above the
class leader/facilitator shall be entitled to any compensation as described in section # 3 above
and accrued up to the effective date of termination. If the termination was due to the death of
the class leader/facilitator such accrued compensation shall be paid to her/his executor or
administrator or, if no executor/administrator has been appointed, then to a personal representative or heir.

6.) Limitation of authority. Class leaders/facilitators shall have no right or authority to bind or otherwise legally commit
Encourager's Co-op, the families or members on any agreement/promise, or other commitmen
whether oral or written.
7.) Agreement renewal option.
This agreement shall automatically expire on without any further action or notice
required by either party. Any subsequent agreement for the following program year shall be

conditioned upon the execution of and subject to the terms and conditions of a new written agreement by the parties hereto. This agreement contains the entire agreement of the parties and fully supersedes any and all prior agreements or understandings, whether oral or written. 8.) Modification and waiver.

No alteration of or modification to any of the provisions of this agreement shall be valid unless made in writing and signed by both parties. The waiver by any party of a breach of any provision of this agreement by the other party shall not operated or be construed as a waiver of any subsequent breach by such party.
